







POLICIES, TERMS AND CONDITIONS

Generally, purchases of sale of any product from Roma Costume by you or any Purchaser, requisites consent of the following terms and conditions:

- All Purchasers must have a valid re-sale number or appropriate re-sale license and/or business license, in good standing, in order for Roma Costume to process any order.
- First time orders must exceed \$300.00. Thereafter, all orders must exceed \$100.00. A \$10.00 surcharge will be assessed on all subsequent purchases which do not meet the \$100.00 minimum. Any merchandise orders of \$100.00 or greater placed by Purchaser, will be automatically backordered, unless advised otherwise. No orders on out of stock merchandise under \$100.00 will be accepted, and will be automatically cancelled. All prices are listed in U.S. Dollars.
- Roma Costume accepts only Visa or MasterCard credit cards. A four percent (4%) processing charge will be applied only to Net accounts which are paid by credit card. In order for Credit card orders to be processed, the order form must include a fully completed and signed authorization, accompanied by a copy of both sides of the credit card and a copy of a valid driver's license or other valid identification card with a picture. All orders on Net accounts must be paid by check.
- Unless otherwise agreed to, on all past due invoices five percent (5%) interest will be assessed per month or the maximum legal interest
 rate permitted by law.
- If Purchaser intends on selling any of Roma Costume's products via the internet or any auction site, prior to doing so, Purchaser must inform and provide Roma Costume of the user ID information, which will be kept confidential. Moreover, the Purchaser must include a statement denoting a "Genuine Roma Product" in both the item listing and the production description, and include applicable notices of copyrights and trademarks as appropriate. Failure to follow these guidelines in its entirety will result in the Purchaser's account being summarily terminated without prior notice and Purchaser may face legal action by Roma Costume, in both law and equity, all rights reserved.
- Following approval by Roma Costume for "Halloween Dating" terms, all orders placed for "Halloween Dating" on or before August 15th, are due and must be paid no later than the second Monday of November. All "Halloween Dating" accounts must pay an initial twenty-five percent (25%) deposit before Roma Costume ships the order, without exception.
- Freight charges for unclaimed and/or refused shipments will be added to Purchaser's next shipment. Shipping charges are calculated for
 each individual ship to address.
- All claims for discrepancies and damages must be made within five (5) business days of receipt of merchandise. Merchandise with manufacturing defects may be exchanged, credited or refunded. Non-defective returns will be subject to a 20% restocking fee. No returns will be accepted without prior authorization. Absolutely no exchanges, credits or refunds will be issued for used products.
- For Halloween products, which are solely designated as such by Roma Costume, all damage claims must be made within fifteen (15) business days of receipt of merchandise. Roma Costumes accepts no returns or claims on Halloween products at any time after October 31st, of the year the merchandise was ordered.
